

STRATEGIC PLAN 2024-2027

The Green Habito Strategic Plan 2024-2027 outlines our roadmap for the next five years, focusing our resources on areas where we can have the strongest impact. This plan strengthens our European work and complements the efforts of our partners at the European level. By aligning our activities with the United Nations Sustainable Development Goals (SDGs) and the European Green Deal, we aim to build a more sustainable, inclusive, and resilient future.

Core Objectives

The Strategic Plan is built around three core objectives, each supported by specific goals and actions:

1. Strengthen the Green Habito Network as a Leading Civil Society Movement

Goal: Establish Green Habito as a visible, resilient, and influential network that drives sustainable development and environmental awareness across Europe.

Actions:

- Expand membership to include more national and regional associations, particularly from underrepresented regions such as Southern, Western, and Nordic Europe.
- Develop a robust communication platform (<u>www.greenhabito.eu</u>) to facilitate knowledge exchange, collaboration, and resource sharing among members.
- Establish a network secretariat with transversal staff functions and five clusters of transnational activity teams to enhance coordination and efficiency.
- Launch flagship events, including the Annual Network Conference and the CSOs Annual Green Habito Award, to celebrate achievements and inspire action.
- Strengthen the network's capacity to cooperate internationally by providing training, tools, and resources to members.

2. Empower Individuals and Communities to Drive Sustainable Change

Goal: Equip individuals and communities with the knowledge, skills, and resources to become active agents of change in their daily lives and local contexts.

Actions:

- Develop and deliver educational programs, workshops, and courses on sustainable development, green growth, and active citizenship.
- Foster social cohesion and inclusion by engaging vulnerable groups and ensuring their voices are heard in sustainability initiatives.
- Promote best practices and innovative approaches to achieving the UN SDGs through case studies, webinars, and publications.
- Support grassroots initiatives and pilot projects that test new ideas and solutions for sustainable living.
- Enhance the capacity of NGOs and civil society organizations to engage in environmental activities and advocate for sustainable policies.

3. Influence European Policies and Practices for Sustainable Development

Goal: Shape how Europe and its nations think and act about sustainable development, green growth, and active citizenship.

Actions:

- Advocate for policies and practices that align with the UN SDGs and the European Green Deal at the national and European levels.
